University General Prohibition

Representation related to the University

14. No student, organization, body or group of students shall, without the prior approval of the Vice-Chancellor, make any representation or other communication, whether oral or written or by any other means, to any public official or to the press or to the public while giving any lecture, speech or public statement or while making any broadcast by sound or picture, in relation to any matter relating to the University or relating to University staff or students, in their capacity as staff or students of the University or related to him in his capacity as a student of the University.

Power of the Principal to give orders, etc., in respect of order and discipline

36 (1) The Principal or any other person authorized by the Vice-Chancellor may, from time to time, give either orally or in writing, such orders, instructions or directions as he/she deems necessary to keep peace and harmony in the hostel.

Disciplinary Punishment

49. A student who commits a disciplinary offense under these Rules and is found guilty of the offense may be subject to any one or any combination of two or more appropriate penalties as follows :

- a) Warning;
- b) the fine does not exceed one (1) hundred Malaysian Ringgit;
- c) prohibited from being or entering any part or certain parts of the University for a specified period;
- d) suspended from being a University student for the determined period;
- e) dismissed from the University

vi. Agree to release the Residential College from any liability arising from my own negligence.
